

Executive Director Commentary

As we move from 2020 to 2021 it is important that we reflect on the challenges and accomplishments of the past year and set goals for the coming year. The past year has been dominated by the onset of the coronavirus and the effect it has had on Housing Authority staff, residents, Housing Choice Voucher Program participants and applicants for housing.

The coronavirus forced the Housing Authority to change the way we do business and learn to live in a new and dangerous world. Zoom meetings, virtual inspections and drop boxes became the new normal way to do business.

Thanks to the amazing staff at the Housing Authority and the resilience of our residents and applicants, we are serving as many families at the beginning of 2021 as we were serving at the beginning of 2020. This would not have been possible without the support of the Department of Housing and Urban Development (HUD) who provided additional funds through the CARES program.

Looking forward to 2021, HACE hopes to be a continuing partner in providing COVID-19 testing, offering vaccines to residents, and supporting residents in returning to a more normal day-to-day life. It is our hope to begin to provide our vast array of social services to residents on a more personal and in-person basis. It is our hope to again plan for what will be our 24th Annual Family Picnic at Waldameer on August 13th and make it a "Back to School Celebration."

HACE goals in 2021 include continuing to research the Rental Assistance Demonstration Program, completing a physical needs assessment of all HACE properties, bidding out up to \$4,000,000 in Capital Fund construction projects to update and improve our public housing properties, continuing to improve the HACE website and make it more resident friendly and maintaining 97% occupancy at all HACE properties.

The most important possession for a family seeking economic and family self-sufficiency is a safe, quality, affordable place to live. HACE provides this for over 3,100 individuals and families in its public housing and Housing Choice Voucher programs. It continues to be our goal to be a partner with our residents as they transition from HACE to their own home. Over forty (40) residents purchased their first home last year, many thanks to the assistance of our Family Self-Sufficiency program. In addition, HACE provided internship opportunities to 19 youth attending college and scholarship assistance to 43 elementary and college-age students in partnership with the Ellen Curry Foundation.

Let's make 2021 a year of hope and accomplishment both individually and for our community. For this to happen everyone must wear their masks, stay home if you are feeling sick, utilize testing sites and get your vaccine when they are available.

- Operate all programs efficiently within budgetary limits; and improve staff productivity and effectiveness.
- 5 Enhance self-sufficency of public housing/Housing Choice Voucher Program tenants and promote greater sense of community and pride among residents.
- Improve neighborhoods surrounding public housing communities.



2021 Agency Plan

On January 6, 2021, the HACE Board of Commissioners approved the 2021 Agency Plan for submission to the Department of Housing and Urban Development on January 15, 2021. This is the end of a yearly process to develop an agency plan that sets Capital Fund Projects in HACE neighborhoods, revises and updates HACE policies and identifies any significant amendments to HACE operations.

The process began with a resident meeting on September 22nd, followed by four Resident Advisory Board meetings and concluded with a Public Hearing on December 29th. All meetings were held virtually utilizing a Zoom Conference meeting format. During these meetings and during a 45-day comment period, residents and the general public had the opportunity to learn about HACE projects and goals and to offer input and ideas to improve conditions in their neighborhoods.

COVID-19 Vaccine Day

The Housing Authority of the City of Erie in partnership with the LECOM Institute for Successful Aging sponsored its first on-site COVID-19 vaccination clinic at Schmid Towers on Wednesday, February 17th. Pharmacists from LECOM administered the shots. Sign-ups were coordinated by HACE Resident Initiatives Coordinator Cherie Kinem and HomePlus Program Coordinator John Pete. 107 vaccines were administered to Schmid Tower residents and HACE staff.

Vaccines will be administered to HACE residents at Friendship
Apartments on February 24th and Ostrow Apartments on March 3rd.

Holiday Activities

COVID-19 did not stop the Housing Authority and its program partners from reaching out to residents during the holiday season.

- The season started with a turkey giveaway at the John E. Horan
 Garden Apartments that was sponsored by Widget Financial and
 Onex Inc. Over 100 turkeys were passed out by staff from Widget
 and Onex along with members of the COPPS Program and staff
 from MCRC, the YMCA and the Housing Authority.
- The Housing Authority sponsored hot meals on Thanksgiving and Christmas for over 500 residents from Schmid Towers, Friendship Apartments and Ostrow Apartments. The meals were prepared by Michael Hooks from Michael Making Life Better and delivered by HACE Resident Initiatives Coordinator Cherie Kinem along with HACE staff, the GECAC HomePlus Program and members of the COPPS program.
- Every year the YMCA Kids Club sponsors Christmas parties
 for over 100 children living in the John E. Horan Garden Apartments, Erie Heights
 and Pineview. Because of COVID-19 it was not possible to have large indoor parties, so staff from the YMCA
 Kids Club, COPPS officers and HACE staff visited over 100 children at their homes to help Santa Claus deliver
 gifts and spread holiday cheer. ONEX Inc. sponsored gifts for twenty (20) of the children.
- The HACE Annual Door Decorating Contest was held at Schmid, Friendship and Ostrow Apartments. Over 70
 residents participated with the winners in each building awarded Visa gift cards.
- Staff from the John F. Kennedy Center delivered gifts to 51 Harbor Homes families. The Quality of Life Learning Center sponsored gift baskets for ten (10) families.

We at the Housing Authority would like to thank our staff, our program partners and the staff from Widget and ONEX Inc. for their overwhelming generosity during these challenging times. You proved that nothing gets in the way of a giving heart.



Despite COVID-19, the HACE Family Self-Sufficiency (FSS) Program Angel Tree event was still able to bring some holiday cheer to 19 youths whose families participate in the FSS program. This is the third year that the event was held. The event was organized by FSS Caseworker Sabrina Ferguson and included 14 staff members who were able to choose their "Angels." The "Angels" had the age, gender, and top three special gifts each youth wanted for Christmas. Staff then purchased and wrapped the gifts to be handed out during December. HACE staff member, Jill Beach and FSS Caseworker Sabrina Ferguson were Santa's little helpers and delivered the gifts to all the households using contactless delivery. In addition to the presents, bags of candy were donated by Eddie Ocasio, Employment Specialist and Coordinator/Team Manager at the Multi-Cultural Resource Family Support Center located in the John E. Horan Garden Apartments. Thank you to Sabrina, Jill and the HACE staff for making these children's day a little more special!






Ellen Curry Foundation Scholarships

The Ellen Curry Foundation is taking applications for the Ellen Curry and Louis J. Tullio Scholarship Programs. Both programs are open to Public Housing and Housing Choice Voucher Program residents.

Ellen Curry Scholarships

The Ellen Curry Scholarship is open to any resident seeking to attend parochial school (Luther Memorial is also included) and scheduled to enter Kindergarten through 3rd grade in September 2021. The scholarships are need based and do not exceed \$2,000. Scholarships are renewed yearly through 8th grade if the recipients remain in the Public Housing or Housing Choice Voucher Programs.



Louis J. Tullio Scholarships

The Louis J. Tullio Scholarship is open to any resident 18 to 24 years of age entering or continuing in college full time in September 2021. Six \$1,250 scholarships will be awarded to high school seniors, undergraduate and graduate students. One of the six Tullio scholarship winners will be selected as the John E. Horan Memorial Scholarship recipient earning a \$5,000 award.




Resident Survey

The Housing Authority in partnership with the Keystone Research Center (KSRC), completed its biennial Safety and Services Survey of Housing Authority resident heads of households who have lived in public housing for more than six months. The survey, which has been administered for over twenty years, measures how safe residents feel in their neighborhood/apartment, how they feel about their interactions with their management office and maintenance department and whether they would recommend their housing to friends and family. Copies of the surveys are available online at www.hace.org.

HACE staff will use the survey conclusions to develop processes and procedures to better serve HACE residents. The 2020 survey shows that HACE residents feel safe where they live, are happy with their interactions with HACE and would recommend their housing to friends and family. The results are measured Authority-wide and by individual development, allowing HACE staff to use the survey to improve the services we offer to our residents.
