Mr. Fraley: I would just say that there have been 175 move-ins so far this year. We are on pace for about 240. Maggie's crew alone moved in 3 families on Friday and hoping for one today.

BIDS/PROPOSALS RECEIVED

Lead Base Paint Abatement Phase 5 at Harbor Homes

Mr. Fraley: This is the last phase of the million dollar grant we received from the Department of Housing and Urban Development. We received 2 bids, one was from Rules Construction for \$264,900, the other was from Hoffman United for \$214,975. Hoffman also did Phases 1,2 and 3 and Rules is doing Phase 4. We would recommend approving Hoffman United as the low bidder for Lead Base Paint Abatement Phase 5.

Recreation Program at the John E. Horan Garden Apartments and Erie Heights/Pineview

Mr. Fraley: This is a proposal for the 2023-24 After School and Summer Recreation Program at the John E. Horan Garden Apartments and Erie Heights/Pineview. We received one bid from the YMCA of Greater Erie for \$280,000. That is the same amount that we have funded for the last two years. They have done a very good job for us and have been our partner for over 15 years so I would recommend that we accept the YMCA as our provider for that program.

HORAN GARDEN APARTMENTS, BIRD DRIVE, AGNES R. PRISCARO APARTMENTS, AND ERIE HEIGHTS/PINEVIEW, FOR THE PERIOD SEPTEMBER 1, 2023 THROUGH AUGUST 31, 2024, AT A COST NOT TO EXCEED \$280,000.
