Mr. Fraley: This is for gutter cleaning at various locations. We received a partial bid from Hoffman United and bids from Bauer Ventures, A-Team Pressure Washing and Empire Snow Management. We are recommending to the Board that they accept the low bid for each one of the sites. Bauer Ventures was the low bid for AMP 1, AMP 3, Erie Heights, C. Ted Dombrowski, Better Housing East and Better Housing West. A-Team Pressure Washing was the low bid for AMP 2, AMP 4 and Better Housing Old. We are recommending that we accept all the low bids. We did Debarments and checked the references on all of them.

#### Snow Removal at Various Locations

Last year it was Kunco at two sites and JMC at two sites. This year Kunco was the low bidder at all four sites. Last year we paid \$71,525.00 for the four sites. Kunco's bid this year is \$46,600.00 for all four sites. We are recommending that we accept Kunco as the low bidder.

# Security Services at Friendship Apartments and Schmid Towers

Mr. Fraley: We received three bids for Security Services at Friendship Apartments and Schmid Towers. Dusti Dennis and Elizabeth Twohig and I interviewed all three groups. We are recommending that the Board approve Fisher Security Services at a cost not to exceed \$145,600. It will provide unarmed security guards at Schmid Towers and Friendship from 8:00 pm to 4:00 am Monday through Sunday. You can see on the page that we scored each one and then there is a blended score of 91 for Fisher, 81 for Allied and 74 for A&A.

# AFFORADABLE HOUSING MONTH

Right now, we are serving 3,175 families and have over 1,200 people on our waiting list. We are asking for a resolution from the Board recognizing that every month is affordable housing month.

#8137 WHEREAS, THE AUTHORITY PROVIDES AFFORDABLE HOUSING TO 3,175 FAMILIES, AND OUR WAITING LISTS STILL CONTAIN OVER 1,200 ELIGIBLE FAMILIES.

BE IT RESOLVED BY THE BOARD OF THE HOUSING AUTHORITY OF THE CITY OF ERIE THAT THE AUTHORITY RECOGNIZES THAT EVERY MONTH IS "AFFORDABLE HOUSING" MONTH, AND THAT THE AUTHORITY IS COMMITTED TO MAXIMIZE THE AVAILABLE HOUSING FUNDS TO ASSURE THAT WE PROVIDE SAFE AND AFFORDABLE HOUSING TO AS MANY ERIE CITIZENS IN NEED AS POSSIBLE.

# COMMUNITY HEALTH NET DENTAL CLINIC LEASE RENEWAL

Mr. Fraley: We are asking the Board to approve a 5-year lease with Community Health Net for space at 2110 East 10<sup>th</sup> Street. We have a Dental office there in partnership with Community Health Net for going on seven years. We are asking the Board to extend a lease for an additional 5 years beginning November 1, 2023, through October 31, 2028. They fund all the services provided and we assist with the utilities and maintenance.

HORAN GARDEN APARTMENTS, FOR A FIVE-YEAR PERIOD COMMENCING NOVEMBER 1, 2023 THROUGH OCTOBER 31, 2028 FOR THE PURPOSE OF OFFERING LICENSED DENTAL SERVICES.

Mr. Fraley: The only other thing that we have today is the story board for our food insecurity programs. In any given month, we provide some kind of food staple to over 500 individuals and families. I'll give you a good example of how this has been going. At Eastbrook, we started out serving 50 boxes about 6 months ago and now we are up to 140. In these boxes are produce, meat items, desserts. There are only about 80 families at Eastbrook, so we are serving the whole general vicinity now. We are very happy with how this is going. The second group is the Erie Food Rescue Program. They are all volunteers. They get a call from Get Go saying they have prepared food they would like to donate. They bring it to Schmid and may have 40 to 50 people show up and they can choose 3 to 4 items like subs, pizza. Food items they can cook that night. At the bottom is the Widget turkey give away. Widget has been doing this for seven or eight years. These pictures were all taken last Thursday at Eastbrook, you can see one of our police officers assisting a woman and her son deliver the food to their home, you can't beat that kind of service. We have been nominated for a Belamy Award for this program which is the State award for the Pennsylvania Association of Housing and Redevelopment. We did win a NAHRO National Award of Merit for this, we will know Wednesday if we won the PHARA State award.

There being no other comments, the meeting was adjourned upon proper motion at 1:24 p.m.
