Dear Resident:

The Ellen Curry Foundation was created through a bequest from Ellen Curry who served on the Housing Authority Board for 29 years. The main purpose of the Foundation is to provide financial assistance to children of Housing Authority residents for them to attend private elementary schools.

Any child who lives in housing owned or subsidized by the Housing Authority, and is scheduled to enter **Kindergarten**, 1st, 2nd, or 3rd grade in September 2024, is eligible to apply. The scholarship is need based. The scholarship will be renewed annually through the 8<sup>th</sup> grade, provided the selected family remains a resident of public housing or Section 8; and your child remains in good standing with their school.

If you are interested in having a child considered for the Curry Foundation's Elementary School Scholarship Program, please complete the enclosed application, and return it to the Ellen Curry Foundation, c/o The Housing Authority of the City of Eric, 606 Holland Street, Eric, Pa., 16501-1285, on or before Friday, May 21, 2024, 4:30 pm.

Applicants will be scheduled for interviews by the Foundation in June, and scholarship winners will be notified soon afterwards. Applicants are required to tour their first-choice school prior to their scheduled interview with the Ellen Curry Foundation committee.
